 LK put a report together for the Casino to send it to Alberta Liquor and Gaming (ALGC). Lk reported that \$14K for Canada Games was received. No news from CYC on their ASA bill.
 - b. PPax met Hunter, the team captain for Manitoba. He is known to LK.
 - c. Registration on old truck needs to be renewed.

- e. How are events to be communicated via website? E-mail?

i. **Prizes for Alberta Series** – Trophy for others in the series, not just the winners. **Motion:** Set aside \$5,000 dollars for Prizes for the Alberta Series and extend to include Keelboats. - Made by PPax, 2nd GD – **Carried.**

- j. ASA 2nd coach GD to check with Australia if there is interest in a coach coming to work for ASA. Discussion around billeting the coach, a second vehicle and the pay of \$25/hr for coaching time from May to September.
- k. The ASA a trailer and RIB at the coast were moved to save storage.
- Discussion around support for local coaches via ASA scholarship program that local coaches need to apply for. ASA develops coaches, not instructors. Definition of coaches is different from instructors. NCCP has courses and certification program to certify coaches.

 - b. Need budget to allocate \$14k dollars for Canada Summer Games.
 - c. Website has been fixed, but needs to be reviewed to see what might have been deleted after it was fixed.

 - f. Grant application for Canada Summer Games.
 - g. CYC parents get details of events from LK.
