President report	
<ul> <li>2 regattas complete in Alberta series. SL has 50+ members and a Sailing School – Sail Canada thought that they had over 500 members, this was misinformation.</li> <li>Membership and insurance. Moved from secretary to President report</li> </ul>	
<ul> <li>A Sailing School is ONLY a Sailing School and it has ZERO members</li> <li>Instructors at a Sailing School are not members of an MNA (member national authority), they are registered instructors with Sail Canada</li> <li>To race in a regatta a number of variables <i>must</i> be met and I did not create</li> </ul>	
<ul> <li>these rules, these are in the 2021-2024 Racing Rules of Sailing:</li> <li>a. "RRS 46 PERSON IN CHARGE: A boat shall have on board a person in charge designated by the member or organization that entered the boat. See rule 75."</li> </ul>	
<ul> <li>The Canadian prescription to this RRS states: "Sail Canada prescribes that the designated person in charge, if resident in Canada, shall be a member of Sail Canada through either a</li> </ul>	

club affiliated to Sail Canada or such person's Provincial Sailing Association."

- b. "RRS 75 ENTERING AN EVENT: To enter an event, a boat shall comply with the requirements of the organizing authority of the event. She shall be entered by
- c. (a) a member of a club or other organization affiliated to a World Sailing member national authority,
- d. (b) such a club or organization, or
- e. (c) a member of a World Sailing member national authority."

Therefore, unless an instructor is a member of a club affiliated with Sail Canada, they are not allowed to race, nor use the Racing Rules of Sailing (RRS). Some might find that surprising, though it is a privilege, not a right to use the RRS.

As for the matter of insurance, which was stated in the Notice of Race (NoR):

12 Insurance Each participating boat shall be insured with valid third-party liability insurance. The organizing authority does not accept any responsibility for verifying that a boat has valid third-party liability insurance.

This insurance is *not* the insurance that an instructor has to instruct -- the insurance that instructor's pay is for coverage during their work -- it is purely instructor insurance. It has absolutely nothing to do with racing insurance. The comparison is similar to having house insurance and presuming that your car is automatically insured -- they are not related. Skipper's Plan, that Sail Canada has on almost every email that they send out, is somewhere to get this insurance. It is to be for \$2 million and you do require this to race. The NoR is an extension of the RRS, therefore the OA and the 'skipper' are bound by those rules, also -- as well as the Sailing Instructions (SI's).

- It would appear that the instructors from GSS are not members and do not have insurance
- BG was insistent that the instructors came of their own decision and not part of GSS. He said that was their decision and not GSS
- A question was asked about membership and insurance being part of the instructor curriculum. BG and SG to look into it
- BG said it's a learning moment.
- PPax said athletes should not be left at risk because they are competing against people without insurance
