Proposal: Rhombus Symbol for Alberta Female Laser Sails

September 15, 2023

Dear ASA Board

At the 2019 Laser Master Championships in Geelong, Australia, I was introduced to the Rhombus symbol on the women's Laser sails. The Rhombus allowed the women to compete not only against the men in their category, but also compete directly with the women as a separate category. With women seldom winning regattas, this gave them a distinct recognition.

On the water, the Rhombus symbol on the sail allowed women to recognise with whom they were competing for the female competition.

I believe the Rhombus symbol is a great acknowledgement of female sailors and pride of "being a female sailor". We should follow this policy in Alberta. Thus I propose that:

- **ASA promote Alberta female sailors to use Rhombus symbols on their laser sails and that the females compete against each other as an additional category.**
- **Initially, ASA will purchase for the Laser sail Rhombus symbol and provide them free to interested ASA Laser female members or to ASA clubs with competitive sailing schools using Lasers for females.**

I contacted an American Laser distributor, USOneDesign. They are willing to sell us the official Laser Rhombus symbol for US\$.50 each plus shipping.

After making enquiries with CYC, WSC, GSC and Glenmore Sailing School, we would need about 60 Rhombus (2 per sail). About 6 sails would be designated for clubs where girls borrow the club or school Sails. Thus I suggest that we order 100 to cover those we missed and future needs.

$100 \times \$.68 \text{ CAN} = \$68 + \$3.40(\text{GST})\71.40 plus shipping and border costs.

Once ASA approves the proposal, I can handle the ordering.
