Her son Weston is a sailor and Tawny travelled to the Cork Regatta last summer, providing ASA with some great Instagram posts.</li> <li>Soundbuoys were described and discussed. They are useful for finding marks when a sailor's vision is limited; they are legal and not terribly loud. They are being built in New Zealand and cost about \$3,000.0 NZ dollars. There is another recently developed alternative available, which is a type of eyeglasses, but pricing is unknown.</li> <li>Sophie submitted a proposal for the winter months, including educating coaches, communication with athletes, and training. Sophie would like to help coaches all over Alberta, and possibly spend some weekday time at CYC during the summer. Her plan is to "coach the coaches" and she will complete her Development Coach Course in the coming months. She is hoping to be able to keep sailors/athletes engaged as they get older. There will be a lot of work to do to prepare for the Canada Summer Games. Hours for the winter would be about 20 per week, and 20 per week during the summer, excepting regattas. She would also communicate regularly through the newsletter.
