#### HAVE CONCERNS?

#### **CANADIAN SPORT HELPLINE**

The Canadian Sport Helpline, funded by the Government of Canada, is a confidential listening and referral service monitored by live operators from 8 am to 8 pm Eastern time, 7 days a week. Users will have a choice of communicating via a toll-free phone line, email, text, or live chat, in the official language of their choice.

<u>Situations involving a member of any registered Coach/Instructor or Official (or a Sail Canada staff or volunteer)</u>

Individuals above have been asked to agree to be an UCCMS Participant and abide by the Universal Code of Conduct and are subject to the process created by Sport Canada and the Office of the Sport Integrity Commissioner.

#### All other situations

Sail Canada and the Provincial Sailing Associations have appointed an Independent Third Party who any participant can contact to discuss incidents of maltreatment or misconduct of any kind.
